## Notice Concerning Dividends of Surplus

Daikin Industries, Ltd. (hereafter: the Company) hereby announces that it has resolved, at a meeting of the Board of Directors held on May 12, 2026, to pay dividends of surplus with a record date of March 31, 2026. The matter will be submitted to the Ordinary General Meeting of Shareholders to be held on June 26, 2026. The details are described below.

### 1. Details of dividends

### 2. Reason

The Company's basic policy regarding the determination of dividends from retained earnings is to strive for the realization of continuous dividend increases while placing importance on stability and maintaining awareness of the level of the dividend payout ratio, based on past dividend performance.

Regarding the dividend per share for the fiscal year ending March 31, 2026, the Company announced on May 8, 2025, that the total annual dividend would be 330 yen per share. The breakdown of the annual dividend of 330 yen is 165 yen per share at the end of the second quarter and 165 yen per share at the fiscal year-end.

Since the Company's net sales and the operating income for the fiscal year ending March 31, 2026, reached a record high, the Company has revised its year-end dividend for the current fiscal year to 175 yen per share, an increase of 10 yen per share from the latest dividend forecast of 165 yen per share.
